

END USER LICENSE AGREEMENT

Please read the terms and conditions of this end user license agreement ("EULA") carefully before using this application ("UKG App") as this EULA forms a legally binding license agreement between you ("You") and UKG Inc. or its affiliate ("UKG") that is providing services to the customer entity ("Customer") that provides You with access to the UKG hosted cloud environment ("Cloud Environment") through this UKG App. This EULA governs Your use of the UKG App. By downloading, installing, or using the UKG App, You agree that Your use of the UKG App is subject to and governed by all of the terms and conditions stated in this EULA. If You do not agree to these terms, do not use the UKG App and delete it.

Your use of the UKG App is further subject to and governed by the agreement between UKG or its authorized reseller and Customer ("Master Services Agreement"). In order to use this UKG App You must be an authorized user of Customer. Nothing in this EULA amends, or provides additional rights or obligations under, any Master Services Agreement, and to the extent of any conflict between this EULA and any Master Services Agreement, such Master Services Agreement will control.

1. **LICENSE.** Subject to this EULA and any terms, conditions or policies of the third party app store or other platform from which You downloaded the UKG App ("App Store"), UKG grants to You a limited, non-exclusive, non-transferable, non-sublicensable, revocable license to use the UKG App on a supported device that You own or control to access and use the Cloud Environment solely for Customer's internal business purposes. Your right to use the UKG App is further subject to any terms, conditions, or policies of Customer governing Your access and use of the Cloud Environment. The terms of this EULA will govern any updates and/or upgrades provided by UKG that replace and/or supplement the original UKG App, unless such update/upgrade is accompanied by a separate license in which case the terms of that license will govern.
2. **LICENSE RESTRICTIONS.** You may not (a) remove or modify any marks or proprietary notices of UKG, (b) provide or make the UKG App available to any third party, (c) assign this EULA or give or transfer the UKG App or an interest in them to another individual or entity, (d) decompile, disassemble, adapt, translate, or reverse engineer (except and only to the extent any of the foregoing restrictions is prohibited by applicable law) the UKG App, (e) attempt to derive the source code of, modify or create derivative works of or based on the UKG App, or any party thereof, or (f) use any name, trademark or logo of UKG.
3. **INTELLECTUAL PROPERTY.** You acknowledge and agree that UKG has and shall maintain sole and exclusive ownership and all rights, title, and interest in and to the UKG App and the Cloud Environment, and all modifications and enhancements thereof including all intellectual property rights thereto.
4. **SUPPORT.** UKG has no obligation to provide installation, maintenance or other support services to You; however, UKG may offer limited support to You for the UKG App, in its sole discretion, by providing updates, patches, bug fixes and new versions via the App Store. The App Store has no obligation to provide installation, maintenance or support for the UKG App, but where UKG provides such updates, patches, fixes or new versions through an App Store, the availability may depend on the App Store, for which UKG is not responsible.
5. **TERMINATION.** The EULA is effective until terminated. UKG may terminate this EULA and/or Your ability to access the Cloud Environment through the UKG App at any time in its sole discretion and without liability. This EULA will also automatically terminate upon (a) Your failure to comply with the terms of this EULA, (b) the termination of the Master Services Agreement, or (c) the termination by Customer of Your right to access and use the Cloud Environment. Upon termination of the EULA, You shall cease all use of the UKG App, and delete all copies of the UKG App. Upon such termination, all provisions of this EULA, except for the license to use the UKG App, will survive termination.

6. **DISCLAIMER OF WARRANTY.** YOU EXPRESSLY ACKNOWLEDGE AND AGREE THAT YOUR USE OF THE MOBILE APP IS AT YOUR SOLE RISK. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE MOBILE APP AND ANY SERVICES PERFORMED OR PROVIDED BY THE MOBILE APP ARE PROVIDED TO YOU "AS IS" AND "AS AVAILABLE," WITH ALL FAULTS AND WITHOUT WARRANTY OF ANY KIND. UKG HEREBY DISCLAIMS TO YOU ALL WARRANTIES AND CONDITIONS WITH RESPECT TO THE MOBILE APP AND ANY SERVICES, EITHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, ANY WARRANTIES AND/OR CONDITIONS OF MERCHANTABILITY, TITLE, OF SATISFACTORY QUALITY, OF FITNESS FOR A PARTICULAR PURPOSE, OF ACCURACY, OF QUIET ENJOYMENT, AND OF NONINFRINGEMENT OF THIRD-PARTY RIGHTS. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY UKG OR ITS AUTHORIZED REPRESENTATIVE SHALL CREATE A WARRANTY TO YOU. SOME JURISDICTIONS MAY NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES OR LIMITATIONS ON APPLICABLE STATUTORY RIGHTS OF A USER, AND SOLELY TO THE EXTENT SUCH LAWS APPLY TO YOU, SOME OR ALL OF THE ABOVE EXCLUSIONS AND LIMITATIONS MAY NOT APPLY TO YOU.
7. **LIMITATION OF LIABILITY.** TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL UKG BE LIABLE FOR PERSONAL INJURY OR ANY DIRECT, INCIDENTAL, SPECIAL, EXEMPLARY, PUNITIVE, INDIRECT, OR CONSEQUENTIAL OR SIMILAR DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROFITS, CORRUPTION OR LOSS OF DATA, LOSS OF USE, LOSS OF GOODWILL, FAILURE TO TRANSMIT OR RECEIVE ANY DATA, BUSINESS INTERRUPTION, OR ANY OTHER LIABILITY, DAMAGES OR LOSSES, ARISING OUT OF OR RELATED TO YOUR USE OF OR INABILITY TO USE THE MOBILE APP, HOWEVER CAUSED, REGARDLESS OF THE THEORY OF LIABILITY (CONTRACT, TORT, OR OTHERWISE) AND EVEN IF UKG HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THE LAWS OF SOME JURISDICTIONS MAY NOT ALLOW THE EXCLUSION OR LIMITATION OF LIABILITY FOR PERSONAL INJURY, OR OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, AND SOLELY TO THE EXTENT SUCH LAWS APPLY TO YOU, SOME OR ALL OF THE EXCLUSIONS OR LIMITATIONS MAY NOT APPLY TO YOU. Without limiting any of the foregoing, in no event will UKG's total liability to You for all damages exceed the amount of one hundred dollars (US\$100.00). The foregoing limitations will apply even if the above stated remedy fails of its essential purpose.
8. **THIRD PARTY INTELLECTUAL PROPERTY RIGHTS.** You acknowledge that UKG, not the App Store, is responsible for addressing any third party claim that the UKG App infringes that third party's intellectual property rights and that the App Store will have no responsibility for the investigation, defense, settlement, or discharge of any such intellectual property infringement claim.
9. **LEGAL COMPLIANCE.** You are responsible for complying with all laws applicable to Your use of the UKG App. You represent and warrant that (a) You will not use the UKG App for any purposes prohibited by applicable law, including, without limitation, for the development, design, manufacture or production of nuclear, chemical or biological weapons of mass destruction, (b) You are not located in a country that is subject to a U.S. Government embargo, or that has been designated by the U.S. Government as a "terrorist supporting" country, (c) You will not download or otherwise export or re-export the UKG App, directly or indirectly, to any prohibited countries, person, end user or entity specified by U.S. Government, and (d) You are not listed on any U.S. Government lists of prohibited or restricted parties.
10. **THIRD-PARTY MARKETPLACES.** If You downloaded the UKG App from a third-party marketplace the following additional conditions apply:
 - a) **Marketplace Processing:** Please be aware that some data processing related to Your use of the UKG App may be conducted by third-party marketplace providers. This processing

is outside the scope of UKG's data processing responsibilities and may not be governed by the same data protection practices as those of UKG. You are responsible for reviewing the privacy policies and terms of service of any third-party marketplace from which You obtain the UKG App.

- b) **US Data Processing:** For users outside of the US, please note that the primary data processing location for the UKG App will be within the United States. UKG has adhered to the Data Privacy Framework, and transfers of personal data from the EU complies with the requirements of Article 46 of the GDPR. By using the UKG App, You consent to the processing of data in the US, even if the UKG App is downloaded from a third-party marketplace hosted in another region.

11. **PRIVACY AND DATA PROTECTION.** All personal information processed by UKG through Your use of the UKG App is managed in accordance with the UKG Global Privacy Notice. This EULA does not apply to how UKG processes personal information on behalf of our enterprise customers in UKG's role as a data processor. If You are an employee, student, or job applicant of an organization that utilizes a UKG product or service and have questions or concerns regarding the personal information Your organization holds about You (where UKG acts as the processor), please contact Your organization directly. UKG is unable to respond directly to such requests.

12. **DATA COLLECTION.** When You use the UKG App, UKG collect's certain information from Your device to enhance the performance and functionality of UKG's services. This includes data such as Your device's make, model, operating system, and available memory. To further improve Your experience and troubleshoot issues, the UKG App assigns a unique identifier to Your device. Please note that UKG does not use any information collected from the UKG App for targeted advertising purposes.

- a) **Purpose and Legal Basis Under Data Protection Law:** UKG processes Your personal information in reliance on our legitimate interests to:

- Detect crashes, resolve technical issues, and improve overall user experience with UKG's applications.
- Remotely enable or disable features within the UKG App to ensure proper functionality and adapt to user needs.
- If You use a UKG event-related UKG App, UKG may also collect additional information from Your device, such as Your photos, contacts, or geolocation data, in accordance with Your device's privacy settings.

- b) **Purpose and Legal Basis Under Data Protection Law:** UKG processes Your personal information with Your consent (where required by law), to perform or enter contracts or terms of service with You, or if UKG does not have a contract directly with You, in reliance on our legitimate interests to:

- Manage, plan, and host the event, including to send related communications.
- Improve our future events and the UKG App.
- Improve or enhance Your (or Your organization's) experience interacting with UKG.
- Provide You with information about our products (including telemarketing calls and marketing emails, in accordance with Your marketing preferences).

- Your data is processed in accordance with the UKG Global Privacy Notice, which provides additional details on how UKG manages and protect Your personal information.

13. **INTEGRATION WITH OTHER SYSTEMS.** The UKG App may integrate with third-party services or platforms. Such integrations may involve data processing that is subject to the terms and conditions of those third-party platforms. UKG will not be responsible for any data processing or handling by third-party services outside of its direct control.
14. **JURISDICTION & DISPUTE RESOLUTION.** This EULA and Your use of the UKG App will be governed by and is to be interpreted solely in accordance with the laws of the Commonwealth of Massachusetts, without regard to any conflicts of law provisions that would result in the application of a different body of law, and You agree to submit to exclusive venue in the courts in Boston, Massachusetts in any dispute arising out of or relating to this EULA. IF NOT OTHERWISE PROHIBITED BY APPLICABLE LAW, YOU AGREE THAT ANY CLAIM RELATED TO THIS EULA WILL BE RESOLVED ONLY ON AN INDIVIDUAL BASIS AND NOT IN A CLASS, CONSOLIDATED, OR REPRESENTATIVE ACTION, SUIT, OR OTHER SIMILAR PROCESS. The United Nations Commission on International Trade Law, the United Nations Convention on Contracts for the International Sale of Goods, and the Uniform Computer Information Transactions Act (UCITA) will not apply to this EULA.
15. **BETA DISCLAIMER.** If the UKG App is labeled PREVIEW, ALPHA, BETA, PRE-RELEASE, TRIAL, OR SIMILARLY (“Beta App”), UKG has no obligations in connection with or in the course of providing the Beta App. Any expectations and estimates regarding Beta App are based on factors currently known and actual events or results could differ materially. UKG does not assume any obligation to update the Beta App. In addition, any information about the Beta App and its general product direction is subject to change at any time without notice. It is for informational purposes only and shall not be incorporated into this EULA or any contract or other commitment. UKG undertakes no obligation either to develop the features or functionality provided in the Beta App, or to include any such feature or functionality in a future release of the Beta App. You expressly acknowledge that the Beta App has not been fully tested and may contain defects or deficiencies which may not be corrected by UKG. You further expressly acknowledge that UKG may discontinue the Beta App at any time in UKG’s sole discretion and may never make the Beta App available.
16. **MISCELLANEOUS.** You agree that if UKG does not exercise or enforce any legal right or remedy which is contained in the EULA, this will not be taken to be a formal waiver of UKG’s rights and that those rights or remedies will still be available to UKG. You agree that this is the entire agreement between You and UKG and if any provision of this EULA is found to be invalid or unenforceable, then that provision will be removed from this EULA and the surviving provisions will remain effective. You agree that (a) an App Store provider is not a party to this EULA, (b) UKG is solely responsible for the UKG App, (c) an App Store provider and its subsidiaries, are third party beneficiaries of this EULA, and (d) an App Store provider will have the right (and will be deemed to have accepted the right) to enforce this EULA against You as a third party beneficiary hereof, but only if You accept the terms of this EULA as outlined above.
