UKG tip processing manages employee tip reporting by using either a tip compliance or tip declaration method and allows employees to enter tips on transfers, on out punches, or after punching out. The solution also provides an intuitive setup for administering and processing token pools that includes unlimited numbers of token pools and a complete history of token pool entries and allocation.

To prevent Gaming Control Board fines, you need to be certain that your dealers have current gaming licenses and required certifications. UKG tracks employee certifications and scheduling and sends alerts when certifications are about to expire.
